Subject : Filling up the post of Deputy Commissioner of Security (Bomb Detection & Disposal and Squad) on Deputation/Re-employment basis in Bomb Detection & Disposal Squad at Mumbai.

It is proposed to fill up one post of Deputy Commissioner of Security (Bomb Detection & Disposal) in the pay scale of Rs. 14,300-400-18,300/- in the regional office of the Bureau of Civil Aviation of Security on deputation basis for a period of three years or on re-employment. The selected candidate is liable to serve anywhere in India where BCAS has its offices i.e. Delhi, Kolkata, Mumbai and Chennai. Serving Army Officers, if selected for the post on deputation basis will be governed under Ministry of Civil Aviation letter No. CAS-10(1)/87-HQ(SFS)/IGRUA dated 25-4-1988 as amended from time to time. Retired Army officer, if selected for appointment on re-employment basis will be governed by the normal Rules etc. and these personnel will not be entitled to any exclusive privilege in BCAS by virtue of being ex-servicemen.

2. The qualifications prescribed for the post of Deputy Commissioner of Security, Bomb Detection and Disposal Squad are given at Annexure-I and Bio-data proforma is given at Annexure-II. Nominations of the eligible candidates desirous of joining the post, who are clear from vigilance angle, may be sent in the enclosed proforma alongwith the following documents in duplicate with 60 days from the date of this notification:-

- i) Vigilance Clearance Certificate
- ii) Integrity Certificate
- iii) List of penalties (Major/Minor) imposed, if any during the last ten years.
- iv) ACR dossiers or ACRs for the last five years (It may kindly be noted that the Photostat copies of ACRs should be attested by an officer not below the rank of Under Secretary or equivalent on each page)

3. Candidates who apply for the post will not be allowed to withdraw their candidatures subsequently.

Deputation

- (i) Armament and Ammunition Technical officers of the rank of Major of Army Ordnance Corps qualified in long Armament and Ammunition Technical officers' Course and having practical experience in handling of ammunition/explosives including proof, breakdown, repair, investigation and demolition thereof with 3 years experience of instructional duties in improvised explosive devices; or
- (ii) Army officers from the Corps of Engineers in the rank of Major who had undergone Advances Bomb Disposal Course/Combined officers Bomb Disposal Course at the College of Engineering and has served at least for 3 years in a Bomb disposal Unit/Platoon with 3 years experience in improvised explosive devices; or Senior Armament and Ammunition Technical officers of Army Ordnance Corps and having 3 years experience of instructional duties in improvised explosive devices.

(Period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/deptt. of the Central/State Govt. shall ordinarily be two years extendable by one year more)

Re-Employment

- (i) Retired Armament and Ammunition Technical Officers of the rank of Major or above of Ordnance Corps qualified in long Armament and Ammunition Technical Officers Course and having practical experience in handling of ammunition/explosives including proof breakdown, repair investigation and demolition thereof with 3 years experience of instructional duties in improvised explosive devices; or
- (ii) Retired Army officers in the rank of Major from Corps of Engineers who had undergone the advanced Bomb disposal Course/Combined Officers

Bomb disposal at the College of Engineering and have served for at least 3 years in a Bomb Disposal Unit/Platoon with 3 years experience in improvised explosive devices; or

- (iii) Retired senior Armament and Ammunition Technical officer of the rank of Major of Army Ordnance Corps having 3 years experience of instructional duties in improvised explosive devices.

(Re-employment upto the age of superannuation with reference to civil post)

5. **Duties attached to the post:-**

- i) To detect improvised explosive devices in terminal building, aprons, hand baggage etc. to arrange isolation, neutralisation, rendering safe and disposal of the explosive devices.
- ii) To carry out anti-sabotage checks wherever necessary.
- iii) To assist investigating agency in analysing composition of the explosive substance and its design.
- iv) Impart orientation training to Airport Security Staff in detection and handling of explosive substances.
- v) Maintain a close liaison with Department of Explosives.
- vi) Offer expert advice to Commissioner of Security (Civil Aviation) on all matters pertaining to explosives.
- vii) Render assistance to Airport Security Staff in dealing with bombs/explosives and threat thereof.
- viii) Keep abreast with latest developments in the world in methods employed by unlawful elements and counter measures therefor including rendering safe procedures.
- ix) Effective supervision of Bomb Detection and Disposal Squad under him.
